## GREEK VOTERS REJECT BAILOUT OFFER

With almost all the ballots counted, results from the Greek referendum show voters decisively rejecting the terms of an international bailout.

Figures published by the interior ministry showed 61% of those whose ballots had been counted voting "No", against 39% voting "Yes".

Greece's governing Syriza party had campaigned for a "No", saying the bailout terms were humiliating.

Their opponents warned that this could see Greece ejected from the eurozone.

Greek Prime Minister Alexis Tsipras said late on Sunday that Greeks had voted for a "Europe of solidarity and democracy".

"As of tomorrow, Greece will go back to the negotiating table and our primary priority is to reinstate the financial stability of the country," he said in a televised address.

"This time, the debt will be on the negotiating table," he added, saying that an International Monetary Fund assessment published this week "confirms Greek views that restructuring the debt is necessary".

But some European officials had said that a "No" would be seen as an outright rejection of talks with creditors.

Jeroen Dijsselbloem, who heads the eurozone's group of finance ministers, said the referendum result was "very regrettable for the future of Greece".

Germany's Deputy Chancellor, Sigmar Gabriel, said renewed negotiations with Greece were "difficult to imagine".

European Commission President Jean-Claude Juncker will hold a conference call with Tusk, Eurogroup President Jeroen Dijsselbloem and ECB President Mario Draghi on the Greek situation on Monday morning.

## € GREEK NO VOTE HITS EARLY EURO TRADING

The euro fell in early Asian trading on Monday after Greek voters in the previous day's referendum backed the government's hardline stance in talks with the country's eurozone creditors. The euro fell 1 per cent to \$1.10 against the US dollar by 5.15am in Tokyo. Deutsche Bank's George Saravelos said the danger of "unpredictable outcomes" to the Greek crisis had again "materially increased" as a result of the referendum result.

## € ECB TO KEEP TIGHT FUNDING GRIP ON GREEK BANKS AFTER 'NO'

The European Central Bank is likely to maintain emergency funding for Greek banks at its current restricted level, people familiar with the matter said on Sunday, a move that will see lenders run out of cash soon. Although a final decision has yet to be taken and the matter will be the subject of debate when ECB policy setters talk today, they are seen keeping Emergency Liquidity Assistance at its current level, leaving Greek banks, and in turn Athens, with little or no room for manoeuvre.

## COUNCIL OF THE EUROPEAN UNION

- 13:30 a two-day **Informal Meeting of EU Sport Ministers** starts in Luxembourg. Today, the ministers are expected to discuss EU representation in WADA and relations with sport movement (European Convention Center Luxembourg, Place de l'Europe 4).

## EUROPEAN COMMISSION

- The Commission called on Friday for **better application and enforcement of EU legislation on passenger rights**. To assist Member States in bridging the enforcement gap, the Commission adopted **interpretative guidelines clarifying the existing rules applicable to the rail sector**. Commissioner **Violeta Bulc** also invited the Council to move forward with the discussions on a new Regulation on the rights of passengers travelling by air.
- On Friday, the European Investment Fund (EIF) and Banque Internationale of Luxembourg SA (BIL) signed an **agreement to increase lending to innovative small and medium-sized enterprises as well as small mid-caps in Luxembourg**. This is the first transaction in Luxembourg to benefit from the support of the European Fund for Strategic Investments. The new agreement allows BIL to provide €60 million of finance to innovative companies in Luxembourg over the next two years. The loans will be backed by a guarantee of the EIF, enabled by the InnovFin initiative with financial backing from Horizon 2020, the EU's research and innovation funding programme.

## GENERAL COURT OF THE EUROPEAN UNION

- The General Court found that the shareholder loan offered to France Télécom by the French authorities at a time when the telephone operator was undergoing a major crisis cannot be classified as State aid. In that regard the Court annulled the Commission's decision on the ground that it had not correctly applied the test of the prudent private investor. (T-425/04 and T-444/04)
