# TERRORISM HITS ECONOMIC GROWTH, AS COMMISSION UNVEILS SPRING FORECAST

Security concerns and the risk of new terrorist attacks are expected to further damage European economies in the next few months, against a backdrop of the weak economic growth seen in the EU over the last years, the European Commission warned in its spring economic forecasts on Tuesday.

The Commission said that output will continue to grow but will not accelerate "significantly" as the boost from the cheap oil and the euro's depreciation will soon fade away.

The executive expects a GDP growth of 1.6% for the eurozone this year and 1.8% in 2017, compared with 1.6% and 1.9% predicted in the winter forecast.

For the EU as a whole, the economy will grow by 1.8% in 2016 and 1.9% in 2017, compared with 1.9% and 2% expected in the previous forecast.

While Europe recently returned to a precrisis economic level, the situation could easily worsen as risks and uncertainty are "extraordinarily high", Mario Buti, Director General of Economic and Financial Affairs, wrote in the forecast.

The executive underlined that "the impact on confidence of increased security concerns is set to weigh on the growth outlook particularly in some member states."

The largest impact will be felt in Belgium and France, as the Paris and Brussels attacks in November and March respectively damaged consumer confidence and spending.

• On Saturday, the Open Doors Day will take part in European Parliament in Strasbourg.

### **EUROPEAN COMMISSION**

• On World Press Freedom Day, the Commission announced that the theme of the 2016 Annual Colloquium on Fundamental Rights will be 'Media Pluralism and Democracy'. This second Annual Colloquium will be held in Brussels on 17-18 November 2016.

• Yesterday, the Commission announced €3 million in humanitarian funding for a UNICEF and World Health Organisation-led nationwide polio vaccination campaign in Syria.

• The Commission yesterday launched a public consultationon how to make it easier for service providers to provide services across the EU. As announced in the Single Market Strategy, the Commission plans to propose by the end of 2016 a Services Passport to simplify the administrative procedures for service providers who want to expand to other Member States.

• According to the Eurostat, In March 2016, compared with February 2016, industrial producer prices rose by 0.3% in the euro area (EA19) and by 0.4% in the EU28, according to estimates from Eurostat, the statistical office of the European Union. In February 2016 prices fell by 0.7% in the euro area and by 0.6% in the EU28.

• Eurostat estimates that in 2015 carbon dioxide (CO2) emissions from fossil fuel combustion increased by 0.7% in the European Union (EU), compared with the previous year CO2 emissions are a major contributor to global warming and account for around 80% of all EU greenhouse gas emissions. They are influenced by factors such as climate conditions, economic growth, size of the population, transport and industrial activities.
